Entire Agreement

This licence document sets out the complete and legally binding terms governing the use of the licensed images. No other statements, summaries, or representations form part of this licence.

All images on this website are available for licensed use. Licensing permits the use of photographs for specific purposes such as editorial publication, commercial projects, or personal and educational use, under clearly defined terms.

Editorial licences are suitable for non-commercial, informational, or journalistic use, including:

- Newspapers, magazines, and journals
- Blogs and educational platforms
- Documentary projects or non-commercial storytelling
- Books and printed publications

Licences may include:

- Single-use or multi-use permissions
- Digital, print, or both
- Defined territory and language rights
- Fixed duration of use

Editorial licences do not permit advertising, brand promotion, or commercial marketing use.
